No. 20/1-B, situated at Kadamba Road, Bainguinim Old Goa, subject to the following conditions:-

1. That the management of the unit should not cause nuisance to the surrounding areas arising from bad smell, discharge of waste water, solid waste, noise, sound of fan etc. 2. The solid waste/liquids waste shall be disposed off in a proper manner so as not to

cause any health hazards.

3. Waste water should be disposed off properly in a soak pit.

4. Water used for the purpose should be potable.

5. Toilet facilities should be provided.

6. The management should provide valid sanitary cards to all employees.

7. The management shall provide proper uniforms to their employees.

- 8. There shall be sufficient number of filters & water purifier with ultra violet technology of standard I.S.I. make.
- 9. That the entire premises of the establishment shall be maintains clean, free from flies, insects and shall observe recommendations done by Medical officer/Sanitary Inspector during their inspection.
- 10. That the management should co-operate with the Health authorities Food & drugs authorities whenever they visit for inspection.

11. Provision of prevention Food Act 1954 and rule shall be strictly observed.

- 12. That the Establishment shall not keep, sell or provide any tobacco or tobacco related products in any form of Cigars, Cigarettes, Biddles, Gutaka, Hukka etc and to display conspicuous display boards in this regards for the knowledge of their consumers,
- 13. The Management/owner of the Restaurant should adhere to all the conditions stipulated in the Goa Public Rules, 1987 under section 15 Sub Section (a) to (J).

14. The caterers to be instructed to follow all the norms of the Public Health Department with regards to sanitation and hygiene.

15. The generic measures include simple public health measures that are to be followed to reduce the risk of COVID-19 shall be strictly observed, these include:

Use of face covers/masks to be made mandatory. 11.

Physical distancing of at least 6 feet to be followed as far as feasible. Practice frequent hand washing with soap (for at least 40-60 seconds) even 111. when hands are not visibly dirty. Use of alcohol-based hand sanitizers (for at least 20 seconds) can be made wherever feasible.

Spitting shall be strictly prohibited.

Seating arrangement to be made in such a way that adequate social distancing is maintained.
